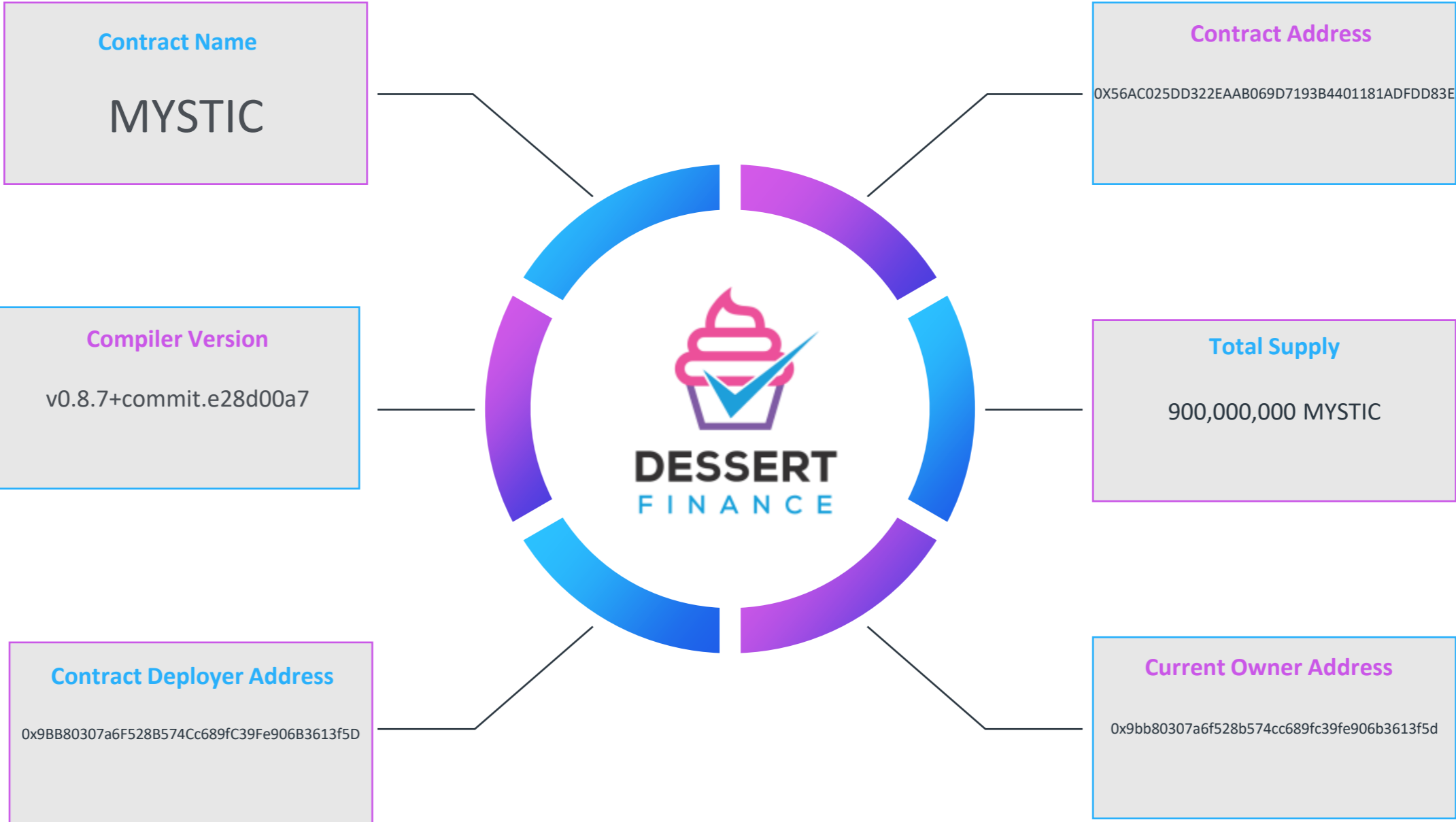

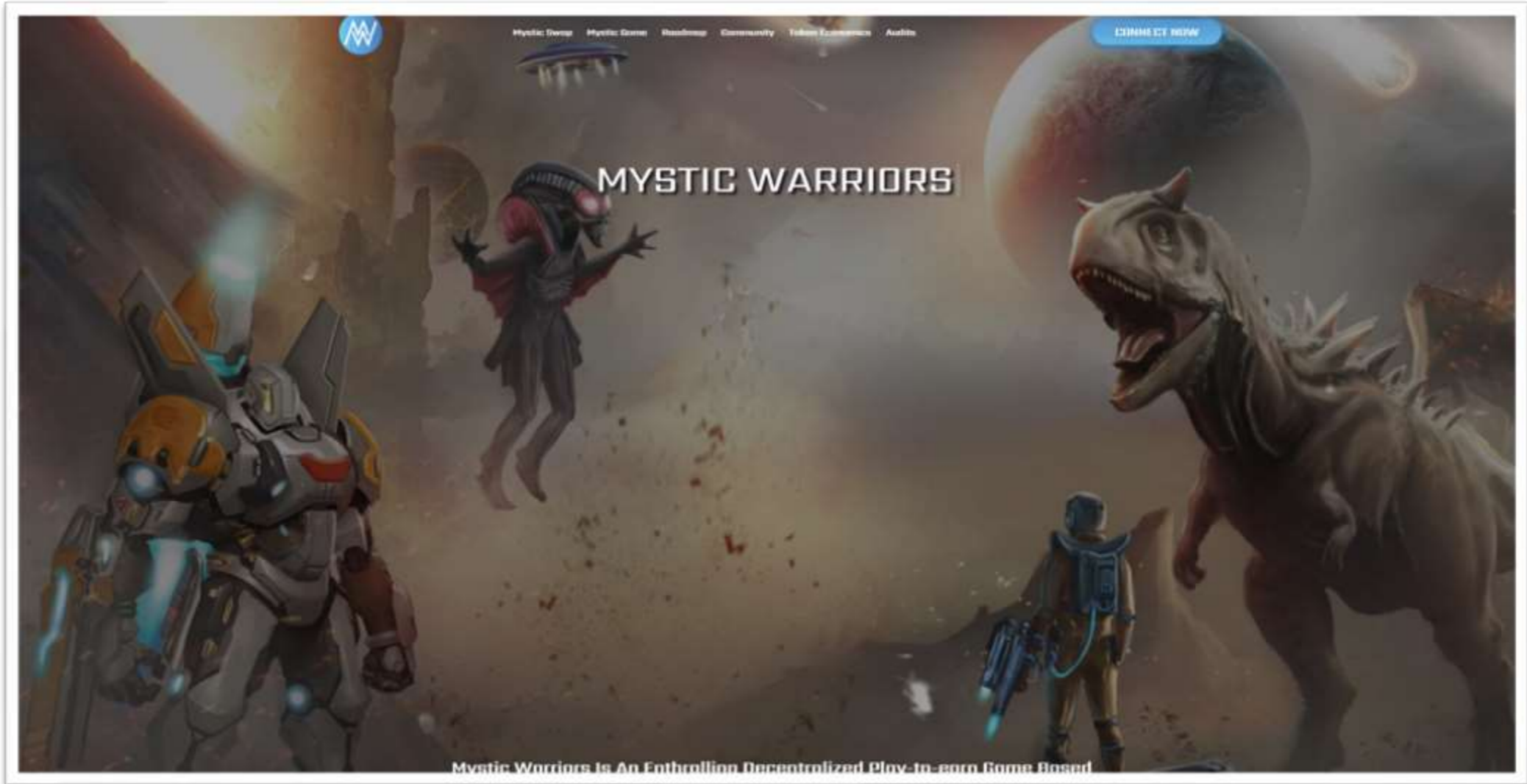


We do understand that sometimes mint functions are essential to the functionality of the project.

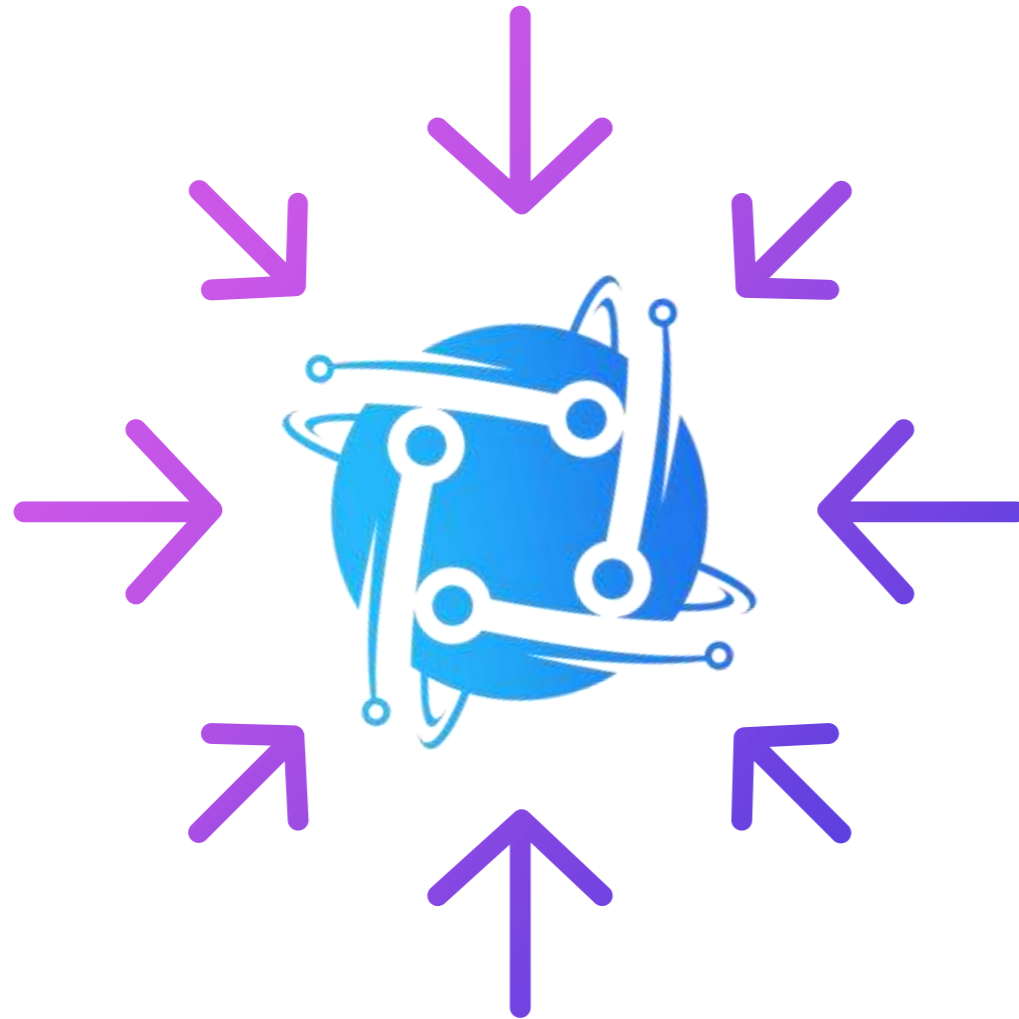


Above images are actual snapshots of the current live website of the project.

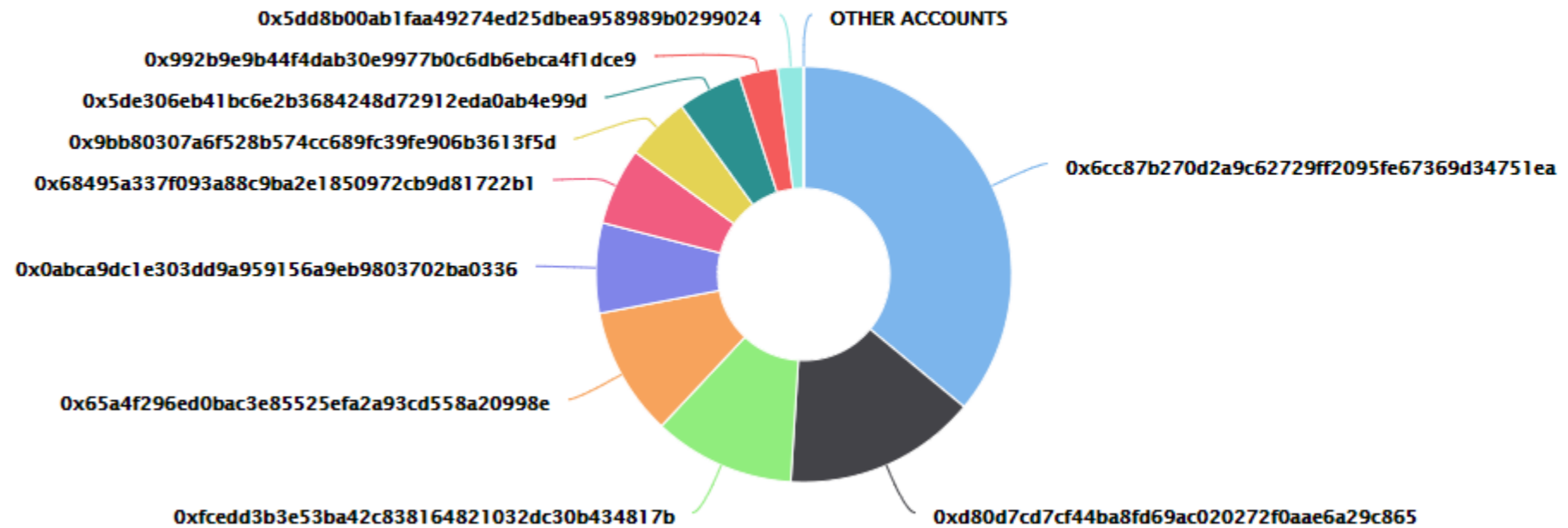

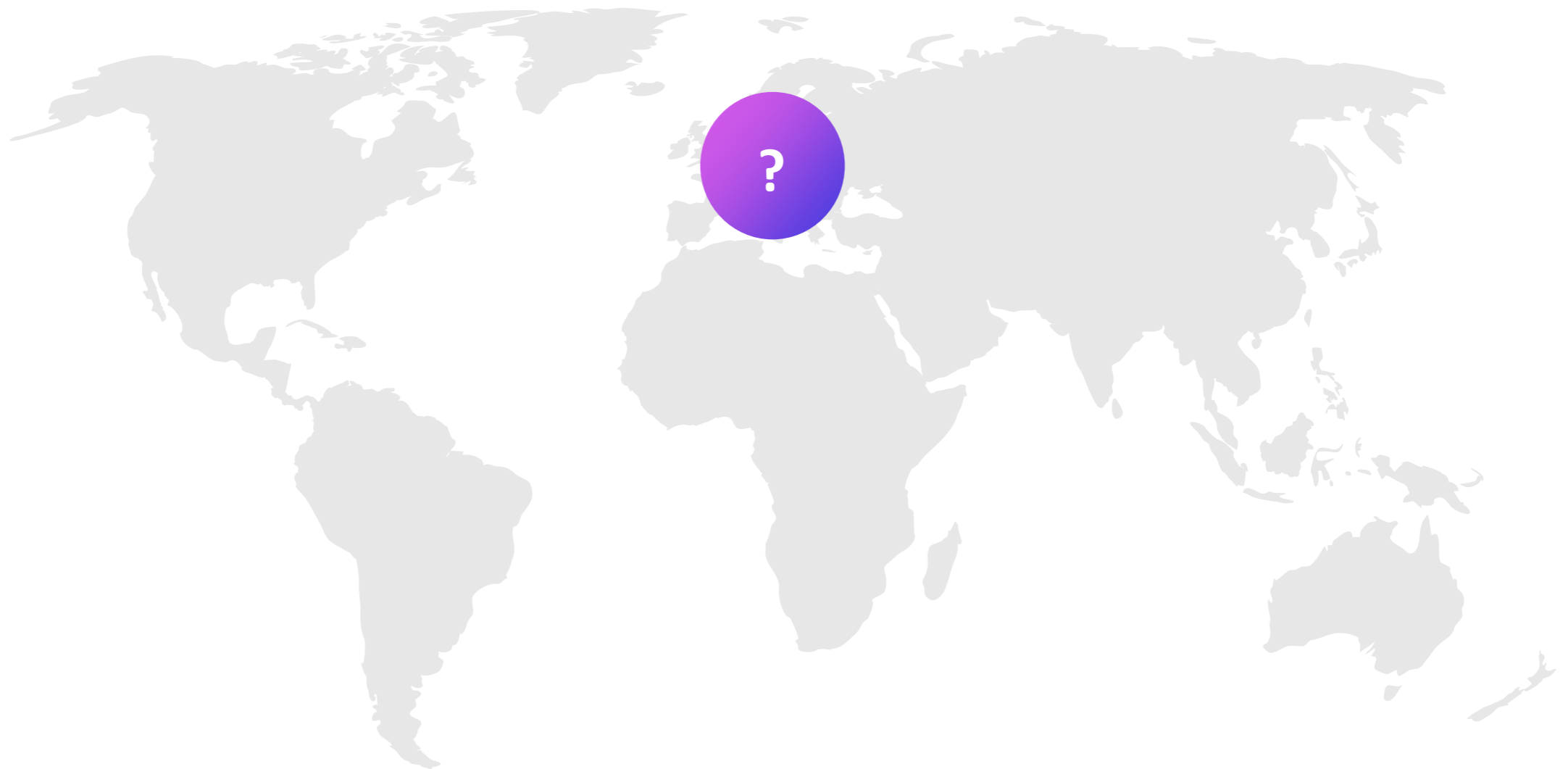
